The Malaysian Government has appointed **MRT Corp.** as the MRT Project Owner and MMC-Gamuda KVMRT (PDP) Sdn Bhd as the Project Delivery Partner ("PDP") who is responsible for the delivery of a fully commissioned MRT system known as "PROJEK MASS RAPID TRANSIT LEMBAH KELANG: JAJARAN SUNGAI BULOH – KAJANG (KVMRT-SBK)". KVMRT-SBK project involves the construction of a railway network which will be the backbone of the Klang Valley's public transportation system to meet the needs of the Rakyat.
