## NOTICE OF PRE-QUALIFICATION

PROJEK MASS RAPID TRANSIT LALUAN 2: SUNGAI BULOH – SERDANG – PUTRAJAYA (SSP) is in line with Suruhanjaya Pengangkutan Awam Darat (SPAD) Urban Rail Development Plan (URDP) of Greater Klang Valley Public Transport Master Plan which connect northern and southern corridor with Kuala Lumpur City Centre via integration with existing railway lines. SSP Line will serve as a backbone system to minimize and alleviate traffic congestion along the highways/roads towards the southern corridor of Klang Valley. It will provide good accessibility to ridership, primarily for job catchment areas, commercial, residential, education centers and recreational areas. SSP Line will traverse through a corridor with a high population density and focus on existing catchment areas that are not served and underserved as identified in SPAD URDP. It will provide and increase local connectivity for future demand and growth centers along the corridor via rail, bus services and operators with integrations to existing and future networks inclusive of Sri Petaling LRT Line, KL MONORAIL, MRT SBK Line, KTM Commuter, Feeder Buses, etc.

Government has appointed MASS RAPID TRANSIT CORPORATION Sdn Bhd (902884V) (MRT Corp.) as the MRT Project Owner and MMC GAMUDA KVMRT (PDP SSP) Sdn Bhd (1117100-V) as the Project Delivery Partner ("PDP") who is responsible for the delivery of a fully commissioned Mass Rapid Transit (MRT) system known as "PROJEK MASS RAPID TRANSIT LALUAN 2: SUNGAI BULOH – SERDANG – PUTRAJAYA (SSP)".

The intent of this Pre-Qualification exercise is to identify and pre-qualify suitable Works Package Contractor (WPC) who shall subsequently be invited to submit competitive tender submission of the various works packages for the proposed construction and completion works of SSP Line.

MRT Corp wishes to invite prospective applicant to participate in a rigorous Pre-Qualification exercise. Applicant is required to submit a duly completed Pre-Qualification Document with comprehensive supporting information. Applicant to take note that participation in this Pre-Qualification exercise does not guarantee invitation to the subsequent stage of Tender Submission. All Pre-Qualification document submissions will be reviewed and scored on the basis of content, completeness and quality. Only pre-qualified applicant will be notified to proceed to the subsequent stage of Tender.

- Applicants must be locally incorporated and comply with the requirements of the Companies Commission of Malaysia.
