In addition to the above Tender requirements, Applicant **MUST** also fulfil the Mandatory Criteria as follows:

Track Record
(a) Experience in completion of supply and installation of furniture contracts within the last 5 years for a minimum cumulative value of RM 1 million; and
(b) Experience in completion of supply and installation of furniture contract with a minimum value of RM 0.5 million in a single contract.

Notes:

- Tenders are invited from experienced Contractors registered under the specified registration details as stated in the above table, which is still valid and allowed to tender at the point of tender.
- Tenderers are required to attend a **COMPULSORY** tender briefing as per detail above.
- The Tender Documents will be displayed and made available for purchase from the date, time and location specified in the above table. Tenderers can view the Tender Documents prior to purchase.
