NOTICE OF TENDER

Mass Rapid Transit Corporation Sdn Bhd ("MRT Corp.") is a wholly-owned Malaysian Government company established by the Ministry of Finance to facilitate, undertake and expedite public infrastructure project approved by the Government. The Malaysian Government has appointed MRT Corp. as the MRT Project Owner and MMC-Gamuda KVMRT (PDP) Sdn Bhd as the Project Delivery Partner ("PDP") who is responsible for the delivery of a fully commissioned MRT system known as "PROJEK MASS RAPID TRANSIT LEMBAH KELANG: JAJARAN SUNGAI BULOH – KAJANG (KVMRT-SBK)". KVMRT-SBK project involves the construction of urban rail transit network which will be the backbone of the Klang Valley's public transportation system to meet the needs of the rakyat. Its seamless connection will be able to contribute towards making Kuala Lumpur a world-class city, supporting its growth and enhancing rakyat productivity.

- Tender Documents shall only be sold to Tenderers who attended the tender briefing. MRT Corp. **SHALL NOT** entertain any requisition for the purchase of Tender Documents before and/or after the time as stipulated.
- The Tender Documents will only be sold to a "bona fide" representative of the Tenderers. For this purpose, a Letter of Authorisation to purchase the Tender Documents **MUST** be produced by Tenderers' representative together with valid **'ORIGINAL'** and **'CERTIFIED TRUE COPY'** (certified by the **Company Secretary or Group A Government Servant**) of the relevant registration certificates of **"Perakuan Pendaftaran Kontraktor (PPK)" and "Sijil Perolehan Kerja Kerajaan (SPKK)" from CIDB and "Sijil Taraf Bumiputera (STB)" from BPKU (formerly known as PKK)** to confirm the Tenderers' qualification.
- All Tenderers shall observe and comply with statutory requirements, rules and regulations, including any modifications to it or re-enactment that is enforced by the Government of Malaysia.
- Tenderers are reminded that certificates which are certified as true copies by the Commissioner of Oaths will **NOT** be accepted. This is in line with the instruction by the Mahkamah Persekutuan Malaysia [Ruj.(44) dlm JK/MP 53/WP(140/97), 23 June 2005].
