**MASS RAPID TRANSIT CORPORATION SDN BHD** (902884-V)(MRT CORP) was set up by the Government of Malaysia to be developer and asset owner of the Klang Valley Mass Rapid Transit (KVMRT) Project. The company is wholly owned by the Minister of Finance Incorporated.

The KVMRT Project involves the construction of a rail-based public transport network in the Klang Valley. The **MRT SUNGAI BULOH-SERDANG-PUTRAJAYA LINE (SSP Line)** is the second MRT line to be developed after the construction of the MRT Sungai Buloh-Kajang Line (SBK Line) began in 2011.

For the development of the SSP Line, **MMC GAMUDA KVMRT (PDP SSP) SDN BHD** (927050-H) has been appointed as the Project Delivery Partner (PDP).

MRT Corp wishes to invite prospective applicants to participate in the Pre-Qualification exercise. The intent of this Pre-Qualification exercise is to identify and pre-qualify suitable Work Package Contractors (WPC) which will subsequently be invited to submit competitive tenders for the work package stated in the table below.

Each applicant is required to submit a duly completed Pre-Qualification Document with comprehensive supporting information. The applicant must take note that participation of this Pre-Qualification exercise does not guarantee invitation to the subsequent tender exercise.

All Pre-Qualification Document submissions will be reviewed and scored on the basis of content, completeness and quality. Only applicants who are successful in this Pre-Qualification exercise will be notified to proceed to the subsequent stages leading to the tender submission.
