NOTICE OF TENDER

Mass Rapid Transit Corporation Sdn Bhd ("MRT Corp.") is a wholly owned Malaysian Government company established by the Ministry of Finance to facilitate, undertake and expedite public infrastructure projects approved by the Government. The Malaysian Government has appointed MRT Corp. as the MRT Project Owner and MMC-GAMUDA KVMRT (PDP) SDN BHD as the 'Project Delivery Partner' ("PDP") who is responsible for the delivery of a fully commissioned MRT system known as "PROJEK MASS RAPID TRANSIT LEMBAH KELANG: JAJARAN SUNGAI BULOH-KAJANG (KVMRT-SBK)". The KVMRT-SBK project involves the construction of an urban rail transit network which will be the backbone of the Klang Valley's public transportation system to meet the needs of the rakyat. Its seamless connection will be able to contribute towards making Kuala Lumpur a world-class city, supporting its growth and enhancing rakyat productivity.
