



NOTICE OF TENDER

MASS RAPID TRANSIT CORPORATION SDN BHD (902884-V) (MRT CORP) was set up by the Government of Malaysia to be the developer and asset owner of the Klang Valley Mass Rapid Transit (KVMRT) Project. This company is wholly owned by Minister of Finance Incorporated.

The KVMRT Project involves the construction of a rail-based public transport network in the Klang Valley. The **MRT SUNGAI BULOH-SERDANG-PUTRAJAYA LINE (SSP Line)** is the second MRT Line to be developed after the construction of the MRT Sungai Buloh-Kajang Line (SBK Line) began in 2011.

For the development of the SSP Line, **MMC GAMUDA KVMRT (PDP SSP) SDN BHD (1117100-V)** has been appointed as the Project Delivery Partner (PDP).

- Tender Documents will only be sold to a "bona fide" representative of the Tenderers.
