Bidders that meet the following criteria and wish to be qualified for the above works are invited to submit duly completed RFQ documents.

- Registered with Ministry of Finance under the code of 221510 (rental and management of car park)
- All Bidders must meet the Bumiputera requirement (51% of shareholding must be Bumiputera)
- Minimum paid up capital of **RM 250,000** (for car park with <1000 parking bay) and **RM 1,000,000** (for car park with >1000 parking bay)
- Minimum experience in operating and managing car park of **three (3) years** (2014,2015 & 2016)

Notes:

- Bidders are invited from experienced Companies registered with and under the specified registration details as per above table, which is still valid and allowed to bid at this point of bidding.
- Bidders are required to attend a **COMPULSORY RFQ** briefing as per detail above.
