

NOTICE OF TENDER

MASS RAPID TRANSIT CORPORATION SDN BHD (902884-V)(MRT CORP) was set up by the Government of Malaysia to be the developer and asset owner of the Klang Valley Mass Rapid Transit (KVMRT) Project. The company is wholly owned by the Minister of Finance Incorporated.

The KVMRT Project involves the construction of a rail-based public transport network in the Klang Valley. The **MRT SUNGAI BULOH-SERDANG-PUTRAJAYA LINE (SSP Line)** is the second MRT line to be developed after the construction of the MRT Sungai Buloh-Kajang Line (SBK Line) began in 2011.

For the development of the SSP Line, **MMC GAMUDA KVMRT (PDP SSP) SDN BHD (1117100-V)** has been appointed as the Project Delivery Partner (PDP).

MRT Corp. wishes to invite prospective Tenderers to participate in the tender for the works package stated in the table below.

The Tenderer (or at least one company in the JV/Consortium) shall have executed one (1) local project over the last ten (10) years with a value more than Ringgit Malaysia: Five Million (RM5 Million) . ii. The Tenderer (or Lead Partner in the JV/Consortium) shall satisfy the mandatory criteria specified in the Schedule of Technical Data. |

Note:

- Experienced contractors that can meet the mandatory criteria and registered with the relevant bodies with the specified registration details as per the above table which are still valid and allowed at the point of tender are invited to participate in this tender.
- Tenderers are required to attend a **MANDATORY** tender briefing at the date, time and place stated above.
- Tenderers are allowed to form a Joint Venture (JV) or Consortium with a local company or locally incorporated or registered foreign owned company or international company **PROVIDED THAT** at least one of the member must have a valid certificate of **Perakuan Pendaftaran Kontraktor (PPK) and Sijil Perolehan Kerja Kerajaan (SPKK) from CIDB with Grade G7, Category ME and specialisation M03** during the tender. However, a JV or Consortium shall not consist more than two (2) companies.
- The locally incorporated or registered foreign owned company must comply with requirement of the Companies Commission of Malaysia (CCM) and CIDB (for Works).
- Tenderers are restricted to submit only one (1) tender either in the form of Single Entity or JV/Consortium.
- Tenderers are not allowed to change the JV Partner/Consortium after the submission of Tender Documents.
- A JV/Consortium submission shall be accompanied with a JV/Consortium Agreement and in the JV/Consortium Agreement must state the lead partner, equity participation of all the members of the JV/Consortium and shall include a clause stating that all members are jointly and severally liable for the JV/Consortium.
- Tender Documents will be displayed and made available for purchase from the date, time and location stated above. Tenderers can view the Table Tender Document (TTD) prior to purchase.
- Tender Documents shall only be sold to Tenderers who attend the tender briefing. MRT Corp. **WILL NOT** entertain any request for the purchase of Tender Documents before or after the date and time stated above.
- Tender Documents will only be sold to a "bona fide" representative of the Tenderer. For this purpose, a **Letter of Authorisation** to purchase the Tender Documents **MUST** be produced by the Tenderer's representative together with valid '**ORIGINAL**' and '**CERTIFIED TRUE COPY**' (certified by the Company Secretary or a Government Grade A Servant) of PPK and SPKK from CIDB to confirm the Tenderer's qualification.
- All Tenderers must observe and comply with statutory requirements, rules and regulations, including any modifications to them or re-enactments that are enforced by the Government of Malaysia.
