

## NOTICE OF TENDER

MASS RAPID TRANSIT CORPORATION SDN BHD (902884-V) ("MRT CORP") was set up by the Government of Malaysia to be the developer and asset owner of the Klang Valley Mass Rapid Transit ("KVMRT") Project. The company is wholly owned by the Minister of Finance Incorporated.

The KVMRT Project involves the construction of a rail-based public transport network in the Klang Valley. The **MRT SUNGAI BULOH-SERDANG-PUTRAJAYA LINE ("SSP Line")** is the second MRT line to be developed after the construction of the MRT Sungai Buloh-Kajang Line ("SBK Line") began in 2011.

MRT Corp. wishes to invite prospective Tenderers to participate in the tender for the works package stated in the table below.

Any late submissions will be disqualified.

In addition to the above tender requirements, Tenderers **MUST** also fulfil the Mandatory Criteria as below:

**Note:**

- Experienced Contractors that can meet the mandatory criteria and registered with the relevant bodies with the specified registration details as per the above table which are still valid and allowed at the point of tender are invited to participate in this tender.
- Tenderers are required to attend a **MANDATORY** tender briefing and site visit at the date, time and place stated above.
- Tenderers are allowed to form a Joint Venture (JV) or Consortium with another Bumiputera company that must also possess *Sijil Taraf Bumiputera (STB)* from *Bahagian Pembangunan Kontraktor dan Usahawan (BPKU)* **PROVIDED THAT** at least one (1) of the member must have a valid certificate of *Perakuan Pendaftaran Kontraktor (PPK) and Sijil Perolehan Kerja Kerajaan (SPKK)* from **CIDB Grade G7 Category & Specialisation CE21 and B04**. However, a JV or Consortium shall not consist more than two (2) companies.
- Tenderers are restricted to submit only one (1) tender either in the form of Single Entity or JV or Consortium.
- Tenderers are not allowed to change the JV Partner or Consortium after the submission of Tender Documents.
- A JV/Consortium submission shall be accompanied with a JV/Consortium Agreement and in the JV/Consortium agreement must state the Lead Partner, equity participation of all the members of the JV/Consortium and shall include a clause stating that all members are jointly and severally liable for the JV/Consortium.
- Tender Documents will be displayed and made available for purchase from the date, time and location stated above. Tenderers can view the Table Tender Document (TTD) prior to purchase.
- Tender Documents shall only be sold to Tenderers who attended the tender briefing and site visit. MRT Corp. **WILL NOT** entertain any request for the purchase of Tender Documents before or after the date and time stated above.
- Tender Documents will only be sold to a "bona fide" representative of the Tenderer. For this purpose, a **Letter of Authorisation** to purchase the Tender Documents **MUST** be produced by the Tenderers' representative together with valid '**ORIGINAL**' and '**CERTIFIED TRUE COPY**' (certified by the Company Secretary or a Government Grade A Servant) of **PPK and SPKK** from **CIDB and STB** from **BPKU** to confirm the Tenderer's qualification.
- All Tenderers must observe and comply with statutory requirements, rules and regulations, including any modifications to them or re-enactments that are enforced by the Government of Malaysia.
- In line with the instruction by the Mahkamah Persekutuan Malaysia [Ruj. (44) dlm JK/MP/53/WP (140/97), 23 June 2005], Tenderers are reminded that certificates which are certified true copies by the Commissioner for Oaths shall **NOT** be accepted.
- By issuing this Notice of Tender, MRT Corp. is not bound in any way and does not have to accept the lowest or any tender.
