- Tenderers are required to submit the duly completed documents with all required supporting information in the format and method as explained in the tender document.

- In addition to the tender requirements, Tenderer **MUST** fulfill all the **Mandatory Criteria** below:

TECHNICAL CRITERIA (MANDATORY)

- Tenderers shall have completed at least one (1) Noise Barrier Project along Railway or Road & Highway with a value of more than Ringgit Malaysia: Three Million (**RM3,000,000.00**) for the past fifteen (15) years in Malaysia or elsewhere.

FINANCIAL CRITERIA (MANDATORY)

- Shareholders' Fund (based on the latest financial year) must not be less than Ringgit Malaysia: Seven Hundred Fifty Thousand (**RM750,000.00**);
- Cumulative EBITDA over the latest 5 preceding years must be positive; and
- Available balance of unutilised credit facilities from the existing Financial Institution must not be less than Ringgit Malaysia: Two Million (**RM2,000,000.00**).

Note:

- Tenderers are not allowed to form a JV/Consortium.
- MRT Corp. reserves the right to reject any submission from any Tenderer without assigning any reason whatsoever or without the obligation to inform the Tenderer of the grounds of rejection or without any liability in any way whatsoever to the Tenderer whose submission is rejected.
