TECHNICAL CRITERIA (MANDATORY)	
1.	Tenderers have completed any relevant Commercial Building Works projects in the last ten (10) years with a minimum of one (1) project value of not less than Ringgit Malaysia: Five Hundred Thousand (RM500,000.00)
FINANCIAL CRITERIA (MANDATORY)	
1.	Average consecutive three (3) months Bank Balance must be positive
