- Experienced in CCTV System project with at least one (1) project valued at a minimum of Ringgit Malaysia Seven Hundred Fifty Thousand (**RM750,000.00**).
- Experienced in Server Hardware implementation project in the local metro railway or other transportation industry within the last five (5) years in Malaysia.

### MANDATORY FINANCIAL CRITERIA

- Shareholder's Funds must not be less than Ringgit Malaysia Fifty Thousand (**RM50,000**)
- Cumulative 5-years EBITDA must be **positive**
