- i. Experienced in Information Technology related **Data Centre** implementation project, with project value more than Ringgit Malaysia One Million Five Hundred Thousand (**RM1,500,000.00**).
- ii. Experienced in Information Technology related (**hardware and software**) implementation project, at least one (1) project in the local metro railway or other transportation industry within the last five (5) years in Malaysia.
- iii. Authorisation Letter from Principal(s) for Conventional Server and Virtualization Infrastructure solution.
- iv. Authorisation Letter from Principal(s) for Hyperconverged Infrastructure (**HCI**) solution.

MANDATORY FINANCIAL CRITERIA

- i. Shareholder's Funds must not be less than Ringgit Malaysia Two Hundred Fifty Thousand (**RM250,000.00**).
- ii. Cumulative 5-years EBITDA must be **positive**.
