1. Tenderers have completed project in installation or maintenance of Fire Detection and Protection Services (FDPS) works in the last ten (10) years with a minimum of one (1) project value of not less than Ringgit Malaysia: One Hundred Thousand (**RM100,000.00**).

### MANDATORY FINANCIAL CRITERIA

1. Average consecutive 3 months bank balance must be positive.
