- In addition to the tender requirements, Tenderer **MUST** fulfill the **Mandatory Criteria** stated below:

MANDATORY TECHNICAL CRITERIA

- The Contractor shall have a proven track record in the supply and install of trackwork equipment or maintenance vehicle with a minimum cumulative project value of Ringgit Malaysia Ten Million (RM10,000,000.00) within the past ten (10) years in Malaysia or elsewhere
- The Contractor shall provide an Authorisation Letter from the Original Equipment Manufacturer (OEM) for the Rail Milling Vehicle.

MANDATORY FINANCIAL CRITERIA

- Shareholder's Funds must not be less than Ringgit Malaysia Two Million Four Hundred Thousand (**RM2,400,000.00**)
- Cumulative EBITDA over the latest five (5) preceding years must be positive
- Available balance of unutilized credit facilities from Financial Institutions and/or available cash of not less than Ringgit Malaysia Seven Million (**RM7,000,000.00**). Unutilised credit facilities shall exclude bank guarantee facilities.

- MRT Corp. reserves the right to reject any submission from any Tenderer without assigning any reason whatsoever or without the obligation to inform the Tenderer of the grounds of rejection or without any liability in any way whatsoever to the Tenderer whose submission is rejected.
