- Experienced in at least one (1) Next Generation Firewall For Network System project, with a project value more than **Ringgit Malaysia Five Hundred Thousand (RM 500,000.00)** in the local metro railway or other transportation industry within the last five (5) years.
- Company's Authorisation Letter from Principal for **Next Generation Firewall** solution.

MANDATORY FINANCIAL CRITERIA

- Shareholder's Funds must not be less than **Ringgit Malaysia Two Hundred Fifty Thousand (RM 250,000.00)**.
- Cumulative 5-years EBITDA must be **positive**.
